What data do we collect?

Heidelberg Model United Nations Society e.V. collects the following data:

- Personal identification information (Name, email address)
- Meta-data (as IP-address)

How do we collect your data?

You directly provide Heidelberg Model United Nations Society e.V. with most of the data we collect. We collect data and process data when you:

- Voluntarily complete a survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Use our social media buttons.

How will we use your data?

Heidelberg Model United Nations Society e.V. collects your data so that we can:

- Answer your questions via our e-mail
- We will retain and evaluate information on your recent visits to our website and how you move around different sections of our website for analytics purposes to understand how people use our website so that we can make it more intuitive

What are your data protection rights?

Heidelberg Model United Nations Society e.V. would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Heidelberg Model United Nations Society e.V. for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Heidelberg Model United Nations Society e.V. correct any information you believe is inaccurate. You also have the right to request Heidelberg Model United Nations Society e.V. to complete the information you believe is incomplete.



The right to erasure – You have the right to request that Heidelberg Model United Nations Society e.V. erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Heidelberg Model United Nations Society e.V. restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Heidelberg Model United Nations Society e.V. processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Heidelberg Model United Nations Society e.V. transfer the data that we have collected to another organization, or directly to you, under certain conditions.
